Club Terms and Conditions:

- Accounts will be debited on the 1st of each month. In the event of the 1st falling on a Saturday, Sunday or recognised public holiday, accounts will automatically be debited on the next business day.
- The subscription term is for a minimum of 6 or 12 months. If after 6 or 12 months, a subscriber wants to terminate his/her subscription, he/she will give a minimum of 1 months' notice in writing. If no notice is received, the subscription will automatically be renewed for another year at the prevailing subscription rates.
- Should a subscriber wish to terminate his / her subscription before the end of the subscription term, a cancellation fee of R 250.00 will be charged. The subscriber will be required to complete, sign and return a cancellation form.
- Free postage / delivery will only be applicable once per parcel. Thereafter, the subscriber's account will be debited with an additional handling and postage / delivery fee of R 50.00 per parcel. Subscribers who paid annually will be notified of unclaimed / returned parcels, and will be required to pay the additional R 50.00 per parcel. After 3 months, all unclaimed parcels will be donated to a charity of Bizzotic's choice.
- Failed debit orders / credit card payments will incur an additional charge of R 30.00 per failed transaction.
- Once parcels have been sent, subscribers will be notified via e-mail. If, after 5 working days, the parcel is not received by the subscriber, it is the subscriber's responsibility to notify Bizzotic so that the parcel can be traced.
- Subscribers will notify Bizzotic of any changes in banking details, delivery addresses or contact details.
